Flexible Rollover Product (FRP) Change of work requirements for Total and Permanent Disablement (TPD) Claims

Super SA regularly reviews the terms and conditions of its product offerings to ensure they meet members' evolving needs. From 1 April 2022 the minimum hours of work requirements have changed for FRP investors to qualify for a Total and Permanent Disablement (TPD) insurance entitlement.

This change is outlined below:

Prior to 1 April 2022:	From 1 April 2022 onwards:
To be eligible to claim a TPD insurance entitlement, an investor must have worked an average of at least 20 hours a week over the 12 month period prior to lodging a TPD claim.	To be eligible to claim a TPD insurance entitlement, an investor must have worked an average of at least nine hours a week over any six month period in the two years prior to lodging a claim.
